

## What are Federal Programs?

- Programs for which a school district receives federal money (which means that it offsets taxpayer costs!) to SUPPLEMENT district programs (ie., for 2023-2024→\$646,025)
- A consolidated application is submitted each year for:
- Title I Part A, Title II Part A, Title III English learners (ELs) and Immigrant Children and Youth (IMM)\*\* and Title IV Part A

## What are Federal Programs? (continued)

- The WPSD plan is to be developed in consultation with teachers, principals, administrators, other appropriate school personnel, and parents of children in schools served with Title I funds
- West Perry is required to review the district plan annually and to make any necessary changes (3 elementary school plans)

\*\*all federal funding includes non-public education consultation/support

\*\*allocations determined by a formula which is based on the federal poverty guidelines and the needs of students attending each school



### Title IA

Helps disadvantaged students meet state academic content and performance standards. The Title I program is a federally funded program authorized under the Elementary and Secondary Education Act (ESEA) of 1965 as reauthorized by the Every Student Succeeds Act (ESSA).

\*\*All three of our elementary schools are Title I Schoolwide Programs (with an early literacy focus)



# Title IA (continued)

In 2023-2024, the WPSD allocation was \$527, 081 for Title I, Part A-Improving Basic Programs

This supports each elementary school with a reading specialist and (Title I) paraprofessionals

Reading specialists work primarily with students K-3



## Title IIA

The purpose of the Title IIA grant is to support teaching and learning

In 2023-2024, the WPSD allocation was \$77,341 for Title II, Part A-Supporting Effective Instruction

This supports our elementary schools with a grade 2-5 Instructional Coach (job-embedded professional development).



## Title IIIA

The purpose of the Title III, Language Instruction for **English Learners (EL) and Immigrant Students, Part A** provides supplemental funds to LEAs to improve the education of EL and immigrant children and youth, by assisting the children to learn English and meet challenging state academic content and student academic achievement standards. The funds support activities that assist EL students in developing English language proficiency in comprehension, listening, speaking, reading and writing, and in meeting the same challenging state academic content and student academic achievement standards as all children are expected to meet.



# Title III (continued)

In 2023-2024, the WPSD allocation was \$2,021 for Title III

\*\*The West Perry School District participates in the CAIU Title III consortium and receives benefits from consolidated funding source and expertise.



## Title IVA

The purpose of the Title IVA grant is to provide all students access to a well-rounded education, improve school conditions for student learning, and improve the use of technology to improve the academic achievement and digital literacy of all students





(3 categories)

Safe and Healthy Students (minimum 20%) Well-Rounded Education (minimum 20%) Effective Use of Technology (at least \$1.00)





In 2023-2024, the WPSD allocation was \$41,603 for Title IV, Part A-Student Support and Academic Enrichment

- Performance Goal (Outcome) Reporting
- Quarterly/Final Expenditure Reports
